Admission Requirements

To qualify for admission, applicants shall normally meet the following requirements:

Academic Qualification

A Bachelor's degree in any discipline from a recognised university or comparable institution, or an equivalent qualification (such as a recognised professional qualification in accounting or finance).


Language Proficiency Requirement

If English was not the medium of instruction for undergraduate studies, applicants should possess evidence of good English of proficiency:

- 1. a minimum TOEFL score of 79 (internet-based); or
- 2. IELTS (academic) overall band score of 6.5; or
- 3. an equivalent score on a comparable test.

Others Requirement

Applicants are preferably with three years of relevant work experience.
