## Internship Programme

## Study Mode

- Full time: one year
- Part time: two years

## Tuition Fee

- Local students: HK\$220,000
- Non-local students: HK\$283,000
- Pre-cores: HK\$5000/ course

## Admission Requirement

- Holders of a Bachelor's degree in any discipline from a recognized tertiary institution, or a qualification deemed to be equivalent
- Applicants needs to demonstrate strong academic performance in undergraduate studies.
- English proficiency: a score of 79 (internet-based test) in TOEFL or an overall band score of 6.5 in IELTS.
